Best use practices

Solution	Rate	Annual Max Rate	Application Notes	
○ KONTOS	5 oz/A	25 oz/A	Start treatments prior to establishment of high-pest population and reapply on an asneeded basis. Apply when pests first appear or when damage is first noticed. For best results, apply mite insecticides with a surfactant and in a water volume of 2 gal/1000 ft². A reapplication in 14 days may be needed if pressure is high.	
TETRINO	32 oz/A	64 oz/A	Apply when adults are detected in early summer, prior to egg hatch. In southern regions, such as FL, multiple overlapping generations can occur and it is best to apply preventive billbug control before turf growth decreases in late summer/early fall. Irrigate or allow rainfall to move product into soil after application.	
TRIPLE CROWN	25 oz/A	50 oz/A	For greater broad-spectrum control, irrigation or rainfall should occur soon after treatment. For greater mite activity, include a surfactant and apply in a water volume of 2 gal/1000 ft² while delaying irrigation for 24 hours.	



Timing applications

Bermudagrass mites and billbugs, while likely present year-round, express damage symptoms most often during periods of decreased turf growth. Late winter/early spring applications should be made at greenup or when symptoms appear. Fall applications should be made prior to dormancy or slowed growth.

Previously damaged turf will require active growth for recovery while applications are meant to reduce future symptom development.
